I attest to the following:

- Our community has a demand for the transported animals.
- Our organization will accept the animals without displacing other animals.
- Our organization has a strong infrastructure of staff and facility to handle the additional adoptions.
- Our organization is 501(c) 3 approved.
- Our organization is in good standing with the community we serve, the animal rescue community, and government agencies.

I agree that the animals transported by DIMC and the crates in which they travel will become our property when they board the plane. At no time does DIMC take ownership of the animals or crates.

I understand that the flying schedule is weather dependent, and schedule changes may need to be made for safety reasons.

I understand that DIMC flies to the following 11 states: MT, WY, CO, NM, AZ, NV, CA, UT, OR, ID, WA, and the west edge of TX

On transport day, I agree to the following:

The representative from our organization who is on the ground

- Will have a cell phone with text ability and be constantly available for updates.
- Will designate one person to coordinate the arrival with other ground personnel.
- Will immediately communicate any changes to DIMC.
- Will arrive to the airport at least 30 minutes prior to the estimated arrival time.
- Will take possession of the crates and communicate with the source organization concerning whether and how they are to be returned.
- Will have water and water bowls available for the animals at the airport.
- Will send transport photos and video if taken to DIMC.
